

## **Purchasing and Licensing Information for DVDs**

### **LICENSING INFORMATION:**

#### **Home Use**

Licensed for personal and home use only. Any screening of the DVD outside the home is prohibited.

#### **Non-Profit Organizations and Community Groups**

Licensed for non-profit organizations and community groups. The license allows for unlimited **free** screenings at one location only and for in-house organizational use. If you wish to screen the film in multiple locations, a license is required for each location. If you wish to charge admission or accept donations at your screening, please contact Cintia Cabib for pricing.

#### **Public Libraries**

Licensed for use in a public library. Includes public performance rights at one location where no admission is charged.

#### **K-12 Schools**

Licensed for classroom use in K-12 schools and for the school's lending library.

#### **Colleges, Universities, Government Agencies, and Businesses**

Licensed for classroom use and free on-campus screenings in a college or university, for use in the institution's lending library, and for in-house use and for in-house use and **free** screenings by government agencies and businesses at one location and for educational purposes only.

#### **Additional Licenses**

If you wish to charge a fee at your event, use the film in a conference or to raise donations, please contact Cintia Cabib to request a quote and a license.

#### **Order Online**

Pay by credit card using PayPal. You do not need to have a PayPal account to order. Please note the shipping and handling fees below.

## **Sales Tax**

Maryland residents are charged 6 percent sales tax. If your organization is located in Maryland and is tax-exempt, please provide documentation with your tax-exempt number.

## **United States Shipping**

There is a \$6.00 shipping and handling fee for the first DVD and \$2.00 for each additional DVD per order.

## **Canada and International Shipping**

There is a \$15.00 shipping and handling fee for the first DVD and \$5.00 for each additional DVD per order. The customer is responsible for all customs fees, taxes and duties.

## **Returns Policy**

All purchases are final, except in the case of a damaged disc, which will be replaced after the damaged disc is returned. Damaged discs must be returned within 14 days of purchase.

## **Public Performance Rights**

A public performance is any showing of the DVD which occurs outside the home, such as in a school, library, or community center. The public performance license is for unlimited non-theatrical, non-commercial, non-broadcast, single-site use via direct projection only. Admission may not be charged.
